The Following terms constitute a sales contract between Yasmin Ireland, Boise French Bulldogs, (hereafter referred to as the seller) and _____ (hereafter referred to as the buyer) regarding the French Bulldog described above. These terms and conditions are entered into and agreed upon by both the buyer and seller and they acknowledge the moral and legal worth of this contract.

Therefore, it is agreed upon that:

1. This dog is sold for the price of \$4,500 with a non- refundable deposit of \$500 due to hold desired pup. Remaining balance of \$ 4,,000 payable upon delivery of the dog, or in accordance with the terms agreed upon in this contract. Boise French Bulldogs does not ground ship. Shipping via puppy nanny and crate charges are the responsibility of the buyer.
2. This dog is a purebred French Bulldog. It is eligible for registration with the American Kennel Club, and the AKC certificate accompanies the dog. This registration is limited as pet only

unless otherwise specified. The buyer agrees to use Boise French Bulldog prefix in the naming of the dog.

3. This dog is sold first and foremost as a beloved pet and family member and is not to be in a kennel situation. The dog is to live with its family in the buyer's living quarters.
4. The buyer is expected to keep vaccinations, worming, heartworm checks and regular examinations by a veterinarian up to date. The dog must always be kept in a sanitary and safe environment.
5. If, for any reason, during the life of the dog the buyer should decide he/she does not want the dog, the buyer will advise the seller and the seller will be given the first right of refusal at the price equal to or less than the original purchase price. At no time will the buyer sell or give the dog to any pet shop, broker, or wholesaler, nor to any individual or entity engaged in research. For no reason should the dog be placed with an individual with known animal cruelty behavior or unsanitary conditions.
6. The buyer agrees to keep the puppy on a biologically appropriate diet. Included in your puppy pack is the puppies current diet along with 100% pure pumpkin NOT pumpkin pie filling. You will receive feeding instruction upon delivery/ pick up of puppy please follow these instructions to avoid and/or alleviate transitional gastrointestinal discomfort.
7. We also strongly recommend a multivitamin with probiotic which is included in your puppy pack.

HEALTH GUARANTEE

This dog is sold with a health certificate from a licensed veterinarian who examined the dog. To the seller's knowledge, this dog is believed to be free of any congenital or contagious disease and has been delivered to the buyer with vaccinations and wormings appropriate for its age. At the option and expense of the buyer, the dog will be taken to their choice of veterinarian for a health exam within 24 hours of their possession of the dog. If a problem is discovered, the buyer must seek a second opinion. If the veterinarians both concur and certify through written documentation that the dog is not physically healthy, then the buyer can return the dog to the seller for a refund within that time period. Any shipping charges and vet charges are the responsibility of the buyer. Health warranty period for this puppy is one year from birth. This warranty covers fatal and life altering congenital diseases. This includes severe hip dysplasia as well as kidney, heart, pancreas, spine and liver problems of a severe, life threatening or altering nature.

If this puppy dies within this contract's effective period, the buyer agrees to assume financial responsibility for necropsy on the puppy, to be performed by a licensed veterinarian to determine cause of death. The buyer agrees to forward written autopsy/ necropsy report to the seller. If the cause of death is found to be any affliction listed under this health warranty the seller agrees to replace the puppy with one of similar identifying characteristics as those of original purchased puppy. Buyer agrees that there is no monetary refund of any kind, full or

partial guaranteed or implied. The puppy must exhibit the congenital defect within the effective period of this contract.

This health guarantee does not apply to any physical problems which could be a result of an injury or exposure to virus/ contagion after the puppy leaves property of seller.

Any specific notes regarding any physical aspects of this dog are indicated here:

HEALTH EXCLUSIONS

The buyer acknowledges that the French Bulldog breed does have common health concerns inherent of all brachycephalic and small dog breeds. These include, but are not limited to: patellar luxation, elongated and/or soft palate, stenotic nares, Von Wildebrands disease, medial entropion (cherry eye), patellar luxation, distichiasis, intervertebral disc abnormalities, and skin and allergy difficulties. The seller does not assume responsibility for any reaction to vaccinations or exposure to Parvovirus or other

The buyer assumes all responsibility and future subsequent treatment for any and all health problems discovered after the initial veterinarian exam.

COMPANION, SHOW OR BREEDING REGISTRATION

This dog is sold as companion only puppy. It is clearly understood that this dog is not being sold for breeding purposes. AKC registration is therefore limited. All companion puppies or dogs must be spayed or neutered by 10 months of age, and proof of alteration sent to the seller.

It is stipulated by and between the buyer and the seller that failing to comply with conditions and terms of the contract will result in the dog being returned to the seller due to lack of compliance and the buyer shall forfeit all monies paid and shall sign over the registration papers immediately to seller.

DEPOSIT AND PAYMENT

By placing a deposit, you are making a legal agreement to purchase one (Male) (Female) French Bulldog. Failure to complete the purchase agreement for any reason; if you change your mind, decide you no longer want the puppy, find out you can not have the puppy or are

able to pay the balance due on the puppy, you will forfeit your deposit. Final payment is due on or before puppy turns 6 weeks of age.

This contract applies to the original puppy or dog and is not transferable to a second party. Buyer agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Idaho, in the county of Ada. It is agreed that the place of venue shall be Ada County, Idaho.

No other warranties or guarantees, expressed or implied, are made under this contract, except as stated therein. This contract is legal and binding.
